A BILL

- To amend title 5, United States Code, to provide direct hire authority to appoint individuals to Federal firefighting and firefighting support positions in the Forest Service or the Department of the Interior, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - This Act may be cited as the "Direct Hire to Fight
 - 5 Fires".

1	SEC. 2. FINDINGS.
2	Congress finds the following:
3	(1) Veterans are an appreciated and sought
4	after population for positions within the Forest
5	Service and in the positions contained in this Act.
6	(2) Veterans deserve expedited hiring and em-
7	ployment.
8	(3) In fiscal year 2020, the use of the Fire Di-
9	rect Hire Authority ("DHA") was on average 31
10	days compared to non-use of the Fire DHA at 51
11	days and overall Forest Service ("FS") hiring at 65
12	days.
13	(4) In fiscal year 2021, the use of the Fire
14	DHA was on average 40 days compared to non-use
15	of Fire DHA at 94 days and overall FS hiring at
16	73 days.
17	(5) In fiscal year 2020, the number of days
18	from authorization to employee entry on duty aver-
19	aged 55 days with the use of the Fire DHA com-
20	pared to non-use of the Fire DHA at 103 days and
21	overall FS hiring at 92 days.
22	(6) In fiscal year 2021, the number of days
23	from authorization to employee entry on duty aver-
24	aged 57 days with the use of the Fire DHA com-
25	pared to non-use of the Fire DHA at 105 days and
26	overall FS hiring at 94 days.

1	SEC. 3. DIRECT HIRE AUTHORITY TO APPOINT INDIVID-
2	UALS TO FEDERAL FIREFIGHTING AND FIRE-
3	FIGHTING SUPPORT POSITIONS IN THE FOR-
4	EST SERVICE OR THE DEPARTMENT OF THE
5	INTERIOR.
6	(a) In General.—Chapter 96 of title 5, United
7	States Code, is amended by adding at the end the fol-
8	lowing:
9	"§ 9603. Direct hire authority to appoint individuals
10	to Federal firefighting and firefighting
11	support positions in Forest Service and
12	Department of the Interior
13	"(a) In General.—The Secretary of Agriculture
14	and the Secretary of Interior may appoint, without regard
15	to the provisions of subchapter I of chapter 33 (other than
16	sections 3303 and 3328 of such chapter), qualified can-
17	didates to any position described in subsection (b) in the
18	Forest Service or the Department of the Interior, respec-
19	tively.
20	"(b) Positions.—A position described in this sub-
21	section is any Federal wildland and structural firefighting
22	position, or any position in support of such firefighting
23	position, within any of the following occupational series
24	(or any successor series):
25	"(1) Forestry Technician Series, GS-0462.
26	"(2) Aircraft Operation Series, GS-2181.

1	"(3) Miscellaneous Administration and Pro-
2	gram Series, GS-0301.
3	"(4) General Natural Resources Management
4	and Biological Sciences Series, GS-0401.
5	"(5) Aviation Management Specialist Series,
6	GS-2101.
7	"(6) Engineering Equipment Operator, WG-
8	5716.
9	"(7) Dispatching Series, GS-2151.
10	"(8) Equipment Specialist, GS-1670.".
11	(b) Clerical Amendment.—The table of sections
12	for such chapter is amended by adding after the item re-
13	lating to section 9602 the following:
	"9603. Direct hire authority to appoint individuals to Federal firefighting and firefighting support positions in Forest Service and Department of the Interior.".
